

# Official Rules and Terms of promotion «Win a Trip to the Maldives for Two and Other Valuable Prizes»

#### I. PRIZES

- 1. Trip to the Maldives for 2 1 unit.
- 2. Romantic dinner at the "New York" restaurant 1 unit.
- 3. Dream night at the Marriott Hotel in Chişinău 1 unit.

## **II. ORGANIZER**

- The organizer of the "Win a Trip to the Maldives for Two and Other Valuable Prizes" lottery is Î.C.S. "Lemi Invest" S.A., legal address: Arborilor Street, 21, Chişinău, Republic of Moldova, identification code 1003600056955, hereinafter referred to as the "ORGANIZER".
- 2. The decision to hold the promotion in accordance with the rules of these Regulations is final and binding for all participants.
- 3. These Regulations are drawn up and published in accordance with the applicable legislation of the Republic of Moldova and are available free of charge upon written request at the Shopping MallDova (Arborilor Street, 21, Chişinău, Republic of Moldova), on the website www.shoppingmalldova.md, and at the info desk (1st floor of Shopping MallDova).
- 4. The organizer reserves the right to change or supplement these Regulations by publishing the changes within one day.

# **III. LOCATION OF THE PROMOTION**

1. The lottery drawing will be held online using the random.org website.

## **IV. PROMOTION PERIOD**

1. The promotion will begin on February 3, 2025, and will end on February 27, 2025. The lottery drawing will take place on February 28, 2025.

## **V. ELIGIBILITY**

1. The lottery promotion is available to any individual who is at least 18 years old and who made a purchase of goods (shoes, clothing, paintings, gold and silver items, and other products available at all stores in Shopping MallDova, excluding

- the following categories: currency exchange, banking services, and casino) totaling at least 1000 MDL in a single receipt within the promotional period.
- 2. Persons under the age of 18, employees of Î.C.S. "Lemi Invest" S.A., shareholders, administrators, and employees of Shopping MallDova, as well as their relatives up to the fourth degree of kinship, cannot participate.
- 3. By participating in the promotion, participants consent to the use of their name, surname, photos, and video materials for promotional purposes without any obligations from the Organizer, including financial ones.

#### VI. PARTICIPATION CONDITIONS

- 1. For each receipt starting from 1000 MDL or more, made at Shopping MallDova, a participant will receive one entry number for the lottery.
- 2. For every 1000 MDL spent in a single receipt, one entry number is issued. Any person who registers the same receipt more than once will be excluded from the participant list.
- 3. A single receipt can be registered by only one participant. A participant can win only one prize.
- 4. Each participant may register no more than 5 receipts in their name during the promotion.
- 5. Receipts cannot be combined to obtain additional entry numbers.
- 6. Only receipts registered on the website www.shoppingmalldova.md are eligible for participation in the lottery drawing.
- 7. Each receipt must be registered separately to obtain a personal entry number.

  The entry number will be sent to the email address provided by the participant.
- 8. For each prize, one winner and two reserve participants will be selected.
- 9. To claim the prize, the winner must present their ID and the receipt with the Shopping MallDova stamp.

- 1. All stores located in the Shopping MallDova are participating in this promotion, except those providing the following services: currency exchange, banking operations, and use of terminal devices.
- 2. The registration form must be completed in full (all fields); otherwise, the entry number for participation in the sweepstakes and, consequently, the chance to win, will be invalid.
- 3. A representative of the Organizer at the Information Desk (1st floor) will check the receipt(s) and, if necessary, the purchased items to ensure that the goods/services were purchased at participating stores in Shopping MallDova and that the amount complies with the participation rules. If all conditions are met, the receipt will be stamped, and the participant will be provided with promotional material containing registration instructions.

4. The Organizer will not allow participation in the promotion if the person presenting the receipt(s) has not purchased goods at Shopping MallDova.

#### VII. PRIZE DRAW MECHANISM

- 1. Prizes will be drawn online using the random.org website.
- 2. For each prize, one winner and two reserve participants will be selected.
- 3. The winner is obliged to participate free of charge in all promotional activities organized by Shopping MallDova (photo and video sessions, posting information on social media, on the Shopping MallDova website, or other advertising platforms).
- 4. The winner will be notified by phone within 72 hours of the draw, after the protocol is prepared by the commission members. If the winner does not answer the first call, they will receive a maximum of 3 calls per day from 9:00 AM to 5:30 PM. If the winner cannot be reached, the Organizer will contact the reserve participants in the order of their selection.
- 5. The winner must claim the prize within 3 calendar days from the date of the phone notification. The participant agrees that the phone calls may be recorded by the Organizer.
- 6. If the winner does not claim the prize within the specified period, does not provide the stamped receipt from Shopping MallDova or an ID, or fails to pay any necessary taxes, the prize will not be awarded. In this case, the Organizer will contact the first reserve participant. The same process applies to the second reserve participant.
- 7. If neither the winner nor the reserve participants meet the conditions for receiving the prize, the prizes remain the property of î.C.S. "Lemi Invest" S.A.
- 8. If a participant wins more than one prize, only the first prize won will be awarded in the order of the draw.
- 9. To claim the prize, the winner must present the receipt with the Shopping MallDova stamp, their ID, and pay all necessary taxes.

### VIII. ERRORS AND DISCREPANCIES IN ADVERTISING

- The Organizer is not responsible for the loss or damage of receipts, their falsification, or for providing receipts that do not meet the conditions of these Regulations.
- 2. Participation in the promotion is only possible if the receipt was issued during the promotional period.
- 3. The Organizer reserves the right to take action against fraudulent attempts, abuses, or actions that may harm the reputation or budget of the promotion.

# IX. FINAL PROVISIONS

- The Organizer is not responsible for paying taxes, except for the income tax withheld at the source of payment, which the Organizer is obligated to calculate, withhold, and transfer to the State budget in accordance with the tax legislation of the Republic of Moldova.
- 2. The winner receives the prize only after paying all taxes.
- 3. By participating in the lottery, participants agree to the terms of these Regulations.
- 4. The Organizer is not responsible for disputes regarding the ownership of receipts.
- 5. Participants registering receipts on the website www.shoppingmalldova.md agree to the processing of their personal data.

## X. DISPUTES

1. In case of disputes between the Organizer and the participants, they will be resolved through negotiations. If an agreement is not reached, the dispute will be submitted to the competent judicial authorities.
